### 11.1. Information on toxicological effects

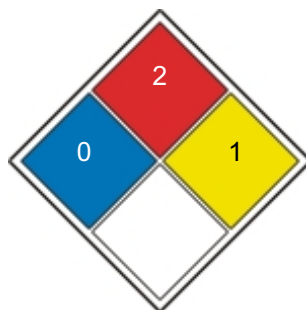
